Where the words **MOVIE NIGHTS** appears in these terms and conditions, read **Seafish Chandlery Limited**

- 1 You must be 16 or over to join, (proof of age may be requested).
- 2 To rent any rental item you and/or your nominated representative should present your membership card and quote your security pin-code. MOVIE NIGHTS reserve the right to refuse to rent any rental item to you and/or your nominated representative without a valid /MOVIE NIGHTS membership card and correct pin-code.
- 3 You may nominate any member of your household to use your card providing you give them your PIN code.
- 4 Other persons using your card and security pin-code must be of the legal age appropriate to the rented item. (Proof of age may be requested)
- 5 You and your nominated representative must keep your security pin-code safe as you will be personally liable to pay for rentals taken out by others using your pin-code.
- 6 All rented items are and shall remain the property of MOVIE NIOHTS and shall be returned to MOVIE NIGHTS by you or your nominated representative in the condition as when hired.
- 7 In the event a MOVIE NIGHTS membership card is lost or stolen at any time or you wish to change your security pin-code, it will be your responsibility to notify the originating store as soon as possible.
- 8 You accept full liability for any and all charges and amounts due to MOVIE NIGHTS which are attributable to the use by you, your nominated representative or a third party of your security pin-code whether such use occurred with or without your knowledge or approval.
- 9 Rented items which are not returned when due will be charged to you at the normal daily rate for each day they remain overdue. If an item is rented at a special offer rate this will end at the conclusion of the offer period. If a rented item is overdue for more than 4 days MOVIE NIGHTS may suspend or cancel your membership.
- 10 MOVIE NIGHTS reserve the right to charge you £20 per rented item if it is lost, stolen or damaged whilst rented under your pin-code.
- 11 MOVIE NIGHTS accept no liability for any loss or damage to property claimed by you or your nominated representative arising from your rental or use of rented items.
- 12 You are required to promptly notify the originating store if you change your address.
